## **Third** Letter in support of the joint 'Request for Investigation' to the ICC from the UK, Slovakia, France and the Czech Republic

Dear Hon. Karim A.A. Khan:

Re. Joint Request for Investigation (United Kingdom (143/21), Slovakia (133/21), France (271/21) and the Czech Republic (326/21))

Please, start prosecution!

We appealed to you on September 20, 2021 and anew on November 29, 2021. Your disregard and inactivity cost literally human lives.

Attached is a letter by the funeral director, Mr. John O'Looney. The letter is another more damning evidence that lives are being sacrificed by the governments and officials to fulfill contracts with mega-rich psychopaths and realize their fantasies about a world with reduced population completely controlled by them.

The attached letter alone provides you with sufficient reasons to start prosecution:

- Mr. O'Looney testifies that he and around 70 colleagues have been experiencing mislabeling of the death causes as Covid,
- Mr. O'Looney testifies that huge financial incentives were offered for Covid being placed on a death certificate;
- Nurses in care homes are to be protected and questioned on the misuse of Midazolam with fatal outcomes;
- There is evidence of grossly negligent misconduct by officials;
- Mr. O'Looney is explicit about the unprecedented accumulation of thrombosis as cause of death – more than in 15 years, he says, short time after “vaccination”;
- The letter contains evidence that the UK government published a tender on October 23, 2021 seeking "*software tool to process the expected high volume of Covid-19 vaccine Adverse Drug Reaction (ADRs)*", i.e., that injuries, serious illness and death were expected and accepted.

Mr. Khan, what is stopping you from saving lives? You are certainly in a position to do so. How would you like to explain to the parents who outlive their children why you allowed this to happen?

**People may forgive a mistake. But, not the deliberate murder of their children.**
