„- A longer solitary confinement can be torture (no. 6 of general comment 20 to the ICCPR). It is degrading inhuman treatment or torture already, if it lasts more than 15 days (no. 57 of the report by Prof. Dr. Nils Melzer von the 20.03.2020 on psychological torture, file number A/HRC/43/49). The solitary confinement of Dr. Reiner Füllmich for months and with sanctions to him and other prisoners even for greeting each other, obviously is torture.

- Also, arbitrariness by public institutions can be torture (no. 62 of file number A/HRC/43/49).

- The severity of torture can also be reached by several measures together, a so-called „torture environment“ (no. 68- 70 of file number A/HRC/43/49).

- The solitary confinement without any sufficient reason, the feet shackles, the untransparent written procedure of the criminal court case and the omitted hearing of important witnesses are arbitrary. The arbitrary parts of the procedures alone already amount to the severity of psychological torture. - Threats and the enforced watching of the torture against others can be torture (no. 46+47 of file number A/HRC/43/49). The violence against friends of Dr. Reiner Füllmich with the presumed aim to intimidate him are torture.

- Only those coercions and hardships can be justified with the detention, which immediately result from the detention, and which necessarily result from closed surroundings; all inmates enjoy the same dignity as the people outside (no. 3 general comment 20 to the ICCPR).

- Prisoners must not be discriminated regarding their human dignity, also not on grounds of their political views (no. 4 general comment 20 to the ICCPR). Solitary confinement as a reaction to criticism regarding the grave human rights violations of the corona policy is a persecution and obviously violates the equality before the law (art. 26 ICCPR).

- The states are obliged to include the prohibition of torture into the professional training also of people working in prisons (art. 10 CAT).“
